



The Moorish Science Temple of America (MSTA) is a religious society organized for the purpose of preserving and transmitting the Moorish nationality of its members, along with the divine creed of Islam.

According to all true and divine records of the human race there is no negro, black, or colored race attached to the human family. What your ancient forefathers were, you are today without doubt or contradiction; and there is no one who is able to change man from the descendant nature of his forefathers; unless his power extends beyond the great universal Creator Allah Himself...

Therefore, Act 6. of the MSTA Divine Constitution & Bylaws mandates that all members must proclaim their nationality. Membership eligibility is exclusively reserved to descendants of the Ancient Moabites (Moorish American), and those Asiatic nations whom confederated with them to found the Moroccan Empire (including: Egyptians, Hindu's of India, Arabians, Turks, Mexicans of North America, Brazilians, Argentinians and Chileans in South America; Columbians, Nicaraguans, and the natives of San Salvador in Central America, etc).

Membership Registration Instructions

You must return your registration form to the Grand Sheik of your local temple, fully filled out and signed. If there is no temple within 2 hours drive from your location, you may fill out, sign, and return your application digitally to theoriginalhomeoffice1928@gmail.com. In either case, you must return your application with all of the following:

- Required finances for Member Dues, Taxes, Emergency Fund, plus any material fees
- Two (2) passport-style photos, 2"x2" (jpg, or png file format);
- Copy of two (2) forms of identification; **or**
- Copy of one (1) form of identification included with a utility bill;
- New registrants must attend the Temple in person to identify your nationality, and hear a reading of the Divine Constitution & ByLaws. If you feel you cannot adhere to all seven (7) acts of our Divine Constitution & By-Laws, you are not eligible and should not apply. If there is no temple near you, your nationality must be verified to our satisfaction

By submitting a signed registration form, you are affirming that:

1. You are a qualified descendant of the Ancient Moabites, or one of those confederate nations noted above
2. You understand the Divine Constitution and Bylaws of the Moorish Science Temple of America, and consent to govern yourself according to all seven (7) of its Acts.
3. You recognize Prophet Noble Drew Ali, as your prophet

MEMBER FINANCIAL OBLIGATIONS



In accordance with the orders of our Prophet Noble Drew Ali, the following information, procedures, definitions and instructions are expressed and explained in written detail so there will be no doubt as to the requirements of each and every Officer and Member of this said Government. The following collections and funds are authorized and can be made in conjunction with the procedures provided to you. Upon submission of your membership application, please include your first months assessment; Per Capita Tax \$5, Membership Dues \$10, Emergency Fund \$2. This amount totals \$17.00 for the first month and each additional month thereafter. All supply orders listed at the end of this document are also due at this time. Below you will find a list of financial obligations with the amount due and our authority to collect... Peace & Love

❖ **Per Capita Tax.....\$5.00 Per Month**

This tax was implemented with the concurrence of the Supreme Grand Council during our first convention, October 1928 and placed into effect November 1, 1928. Due to the fact that operation expenses which were taken care of with fund received from the manufacturing department were found to be a burden on that department. Hence the tax was necessary.

❖ **Emergency Fund.....\$0.50 Per Week (\$2.00 Per Month)**

Prophet Noble Drew Ali put in place a procedure by which every temple would have finance available to use in emergency situations. No other finances are to be used by the heads of temples in emergency situations. This fund will be sufficient for any emergency because if you are faithful Moors, It will increase to over a thousand dollars. Each Temple Head will define and emergency act.

❖ **Membership Dues.....\$10.00 Per Month**

Prophet Noble Drew Ali put in place methods by which the heads of each Temple could support the Local Temple. In the General Laws (Tuesday, October 17, 1928) he stated that membership dues go to the support of the collecting Temple to support its domestic work.

❖ **Uplifting Fund.....Based on Individual Ability**

During the first convention in October 1928, Noble Drew Ali specifically addressed his need for this fund by stating in part that this fund is used to finance the movement. In addition, he made it clear that only He (The Home Office) could issue uplifting fund books. In addition, in Act II of our Additional Laws and Page 7 in your Holy Questionnaire he emphasized the importance of remitting these funds to him by stating, "It takes finance to uplift a Nation". We must help our Prophet in his great uplifting work by subscribing to this fund.

❖ **Public Collection.....Based on Individual Ability**

Prophet Noble Drew Ali has provided each Temple with various means of supporting itself. In the General Laws (October 17, 1928) our Prophet stated that the heads of each Temple are authorized to make this collection and then use it to support the temple and its domestic work. Temples that have favorable public collections have effective membership committees, visitors at every public meeting and members who are effective public speakers who keep the Prophet and his words "up front".

❖ **Sick Collection.....Based on Individual Ability**

As a Religious Corporation, our Prophet made it possible to assist members who find themselves in need of food (due to an inability to work), Medication (due to inability to pay for it) and Transportation. Each Temple must have a sick committee, chaired by an Adept. This Chairman can be contacted by Temple Member or Committee Members to facilitate the disbursement of funds in compliance with a procedure established by the Temple Head and approved by The Home Office.

❖ **Annual Tax.....\$20.00 per year | Special Tax.....\$10.00 Per Year**

Knowing the importance of the National Convention from September 15 – 20 of each year, the officials of the Moorish Science Temple of America have designated these two assessments to be used to off-set Convention expenses. The Annual Tax will be used by the heads of Temples and the Special Tax will be remitted by ALL Temples to the Supreme Business Manager (Home Office) on or before September 1st annually. Delinquent and/or late remittances will not be tolerated due to their negative effect on covering our National Convention expenses.

❖ **Prophet Noble Drew Ali's Birthday Celebration–Jan. 8th.....Based on Individual Ability**

The Heads of ALL Temples are authorized to make a special collection among its member to raise funds to cover expenses for the celebration of our Prophet's birthday on January 8th. The amount requested of members must be within the range approved by the Supreme Grand Council or the Supreme Grand Sheik. You must submit a request to be approved by the Supreme Grand Sheik before you begin collection. While a specific amount may be requested from the members, the collection is based on the members ability to pay. Amounts less than the amount requested by a Temple head should not only be accepted but should be viewed as a member sincerely giving based on his or her ability to give. Traditionally, we have provided a basket on January 8th for members to give monetary funds for a birthday gift to Prophet Noble Drew Ali. If you make a collection you must keep these funds separate from other funds and request disposition instructions from the Supreme Grand Council or the Supreme Grand Sheik.

❖ **National Convention.....As Approved by the Supreme Grand Sheik and/or Supreme Grand Council, September 15–20 (Every Year)...Based on Individual Ability**

Knowing the importance our Prophet designated Temple #1 to host our annual National Convention, the officials of Temple #1 with the concurrence of the Supreme Grand Council, implemented this collection to augment funds collected from the Special Tax.

❖ **Moorish Guide Donations**

As the Prophet instructed, all members must subscribe to the Moorish Guide Newspaper. The MSTA is now taking donations for the support of the development of the Moorish Guide Newspaper. As it was initially designed as a weekly paper, we have now re-established it as a electronic-based periodical. All donations just as in the days of the Prophet, will go toward the National Treasury to support the growth of the Moorish Guide and the Movement.

Moorish Science Temple of America Non-Disclosure Agreement

This Non-Disclosure Agreement is intended to define the responsibilities of those who have access to Temple records that contain sensitive or confidential information about members, employees, donors or other individuals, and to record his or her recognition and acceptance of that responsibility.

The Moorish Science Temple of America maintains the confidentiality and security of its records in accordance with the Family Educational Rights and Privacy Act of 1974 (FERPA), the Health Insurance Portability and Accountability Act (HIPAA) and the Gramm-Leach-Bliley Act (GLBA), in addition to other federal and state laws. These laws pertain to the security and privacy of personal academic, medical and financial information, along with identifying information such as social security numbers.

FERPA protects student records. FERPA requires post-secondary educational institutions and agencies to conform to fair information practices in their handling of student data. Among the provisions of the act are the requirements that data be used only for intended purposes and that those responsible for student data take reasonable precautions to prevent misuse of it. Examples include Social Security Numbers, grades, date of birth, etc.

HIPAA protects all medical records and other individually identifiable health information used or disclosed in any form, whether electronically, on paper or orally.

GLBA protects private, non-public, information of individuals. Private, non-public information consists of information such as name, Social Security Number, date and location of birth, gender, credit card numbers and driver's license numbers.

Within the Moorish Science Temple of America, members are authorized access to records only to the extent necessary to perform their official duties, and are responsible for protecting such information against unauthorized access or disclosure.

Employee/Member: Recognizing this responsibility, I agree to the following (please initial each line):

- _____ I will access records only as required to perform my assigned duties.
- _____ I will not access information that is not necessary to carry out my job. This includes the records of my children, my spouse, significant other, parents, other relatives, friends and acquaintances.
- _____ I will store information under secure conditions and make every effort to ensure individuals' privacy.
- _____ I will not divulge, copy, release, sell, loan, review, alter or destroy records except as properly authorized by the appropriate Temple official within the scope of applicable state or federal laws, record retention schedules and internal policies.
- _____ I will forward all requests for information via an open records request to the university's General Counsel for guidance. I will not release information covered by these requests until instructed to by university's General Counsel or my supervisor.
- _____ When I release member information, I will divulge only the information regarded as "directory" or public information, specifically the member's name, address, telephone listing, date and place of birth, etc.
- _____ I will not release any information about a member who has requested a total suppression of information, nor will I release any optional directory information on an employee who has requested to have his/her directory information suppressed.
- _____ I will not release information about members, staff or employees that was requested on the basis of non-public information.
- _____ I have read the Moorish Science Temple of America's Non-Disclosure Agreement and agree to comply with its provisions. I understand that failure to comply may result in disciplinary action, including termination of employment, separation, and expulsion from this Divine and National Movement.
